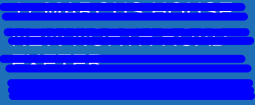

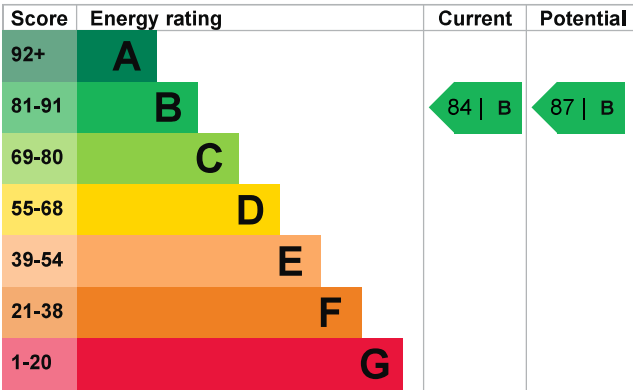

Primary energy use
