

Rules on letting this property


Properties can be rented if they have an energy rating from A to E.

Environmental impact of this property

One of the biggest contributors to climate change is carbon dioxide (CO2). The energy used for heating, lighting and power in our homes produces over a quarter of the UK's CO2 emissions.

By making the <u>recommended changes</u>, you could reduce this property's CO2 emissions by 2.6 tonnes per year. This will help to protect the environment.
