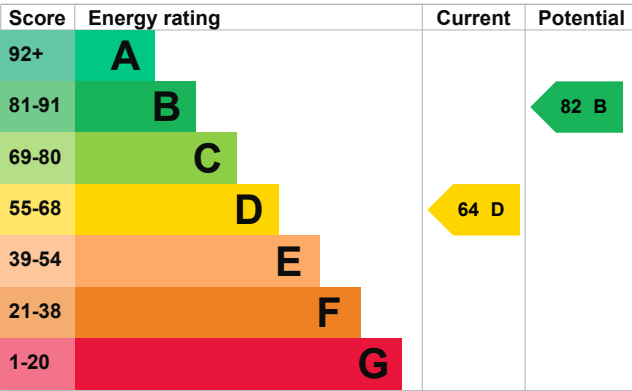

### Primary energy use

## How this affects your energy bills

### Heating this property
