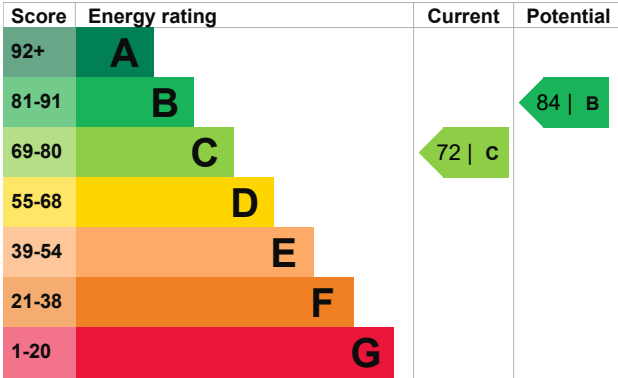

#### Environmental impact of this property
