
# Energy performance certificate (EPC)

Properties can be rented if they have an energy rating from A to E.



## Primary energy use

The primary energy use for this property per year is 344 kilowatt hours per square metre (kWh/m2).

#### • What is primary energy use?

Primary energy use is a measure of the energy required for lighting, heating and hot water in a property. The calculation includes:

- the efficiency of the property's heating system
- power station efficiency for electricity
- the energy used to produce the fuel and deliver it to the property

#### Environmental impact of this property

One of the biggest contributors to climate change is carbon dioxide (CO2). The energy used for heating, lighting and power in our homes produces over a quarter of the UK's CO2 emissions.

This property's potential production	2.2 tonnes of CO2

By making the <u>recommended changes</u>, you could reduce this property's CO2 emissions by 3.2 tonnes per year. This will help to protect the environment.
